<p>REGISTRATION FEES TUITION FEES (Non-refundable) AND STUDY REQUIREMENTS (Mandatory)</p> <p>PAYMENTS:</p> <p>MAKE PAYMENTS TO GARY TAYLOR DANCE</p> <p>Tuition may be paid in full or by monthly auto-draft on a credit or debit card. (Multiple children discount applies only to payment in full). Payments in full qualify for a 5% discount, with the exception of production and summer tuition fees, and is due April 15<sup>th</sup> for the 20-21 season. Monthly payments are due on the 1<sup>st</sup>, past due on the 5<sup>th</sup> and subject to a \$25 late fee after the 5<sup>th</sup>. Upon enrollment, financial responsibility is assumed for all fees for the current term which includes Summer 2020 and 2020-2021 Season tuition, Nutcracker and Spring production fees, and membership fees regardless of early withdrawal. These fees are non-refundable.</p> <p><b>Registration Fee: \$50.00</b> Paid once a calendar year. Due June 1, along with summer application.</p> <p>SUMMER session is June 15- July 10. Should the performer no longer be able to participate, the performer remains responsible for the bill. Costumes will be delivered and distributed during theater rehearsals. All costumes are to remain in the theater until the final performance's completion. Should any costume item be lost, damaged, or misplaced in the theater, the performer is responsible for any additional cost of replacement incurred. Unless otherwise designated, all costumes and/or accessories are the property of Gary Taylor Dance and are to be returned directly to the costuming staff before leaving the theater.</p> <p>Performers are responsible for personal items such as shoes, tights, makeup, hair supplies, and applicable undergarments.
